In the URLs I have provided under the section 'Infringing URLs' you can see how **Pixelbrush** is offering links from known cyberlockers to distribute the work from my CodeCanyon portfolio for free. There is no license on CodeCanyon that would allow this type of activity and this illegal distribution of my work is affecting my sales.

We are asking for your immediate assistance in stopping this unauthorized activity. Specifically, we request you to remove these files from your network/servers, to disable the access to the sites/pages and that you inform the website administrator of the illegality of his or her conduct.
